

# Analysis of Results of the Survey of Tenure-Track Faculty re. the Parking Privatization Initiative at OSU

The full text of the survey is reported below in Appendix 1. The survey consisted of two questions:

1. Do you SUPPORT privatization of OSU parking operations?
  - a. Yes
  - b. No
  - c. I don't know enough about it
  
2. What is your status?
  - a. Faculty
  - b. Staff
  - c. Student

The second question was included to allow us to separate faculty from other respondents, in case the survey were completed by non-faculty personnel.

The survey was conducted using Zoomerang in two overlapping phases between March 27 and April 2. The first phase was a pilot survey of 200 tenure-track faculty (March 27-31) to test functionality; the second phase was the main survey of 2,604 tenure-track faculty (March 28-April 2), not including the first 200. Therefore, a total of 2,804 tenure-track faculty were invited to participate via an email list that was constructed by querying the OSU LDAP server (which contains public information about OSU e-mail addresses, position titles, and some other information for OSU employees and students). For simplicity, the results of the survey will be presented here as the combination of the two phases.

Although the invitation (see Appendix 1) was sent to those the LDAP server listed with tenure-track faculty titles, a total of 88 staff and 24 students also responded. Here we focus on faculty responses. However, purely for reporting purposes, staff and student responses are also summarized separately in Appendix 2.

The responses of tenure-track faculty to question 1 were as follows:

Do you SUPPORT privatization of OSU parking operations?

| Answer                       | Frequency | Percentage |
|------------------------------|-----------|------------|
| Yes                          | 86        | 6.9%       |
| No                           | 1047      | 83.6%      |
| I don't know enough about it | 119       | 9.5%       |
| Total                        | 1252      | 100%       |

The tenure-track faculty response rate was 44.65% (1252/2804).

**It is of note that 92.4% of the faculty who felt they knew enough to take a position did not support the parking privatization plan, and only 7.6% were in favor.**

## Appendix 1: Survey introductory text as it appeared in Zoomerang

| Answer                       | Staff      | Students   |
|------------------------------|------------|------------|
| Yes                          | 3 (3.4%)   | 1 (4.2%)   |
| No                           | 77 (87.5%) | 17 (70.8%) |
| I don't know enough about it | 8 (9.1%)   | 6 (25%)    |
| Total                        | 88 (100%)  | 24 (100%)  |
